1. To delete in their entirety the special provisions set out in section 7 of the Letters Patent of the corporation dated October 31, 1991, and the special provision set out in section 5 of the Supplementary Letters Patent of the corporation dated December 30, 1998, and replace them with the following:

(A) The corporation shall be carried on without the purpose of gain for its members and any profits or other accretions to the corporation shall be used in promoting its objects.

(B) To charge fees, to receive donations, to expend monies, to acquire, hold, and dispose of assets and property, to employ persons, and to take such other actions and make such other agreements as will promote and further the objects and purposes of The Ontario College of Family Physicians, a Chapter of the College of Family Physicians of Canada.

(C) The corporation is authorized to establish four classes of Membership: Practising Members, Non-Practising Members, Learner Members and Associate Members. Practising Members shall be entitled to receive notice of and to attend all meetings of the members of the corporation and each voting member shall have one (1) vote at each such meeting. Non-Practising Members, Learner Members and Associate Members shall not be entitled to receive notice of, attend or vote at meetings of the members of the corporation but may participate on, vote on and chair committees.

(D) Commercial purposes, if any, included in the articles are intended only to advance or support one or more of the non-profit purposes of the corporation. No part of a corporation's profits or of its property or accretions to the value of the property may be distributed, directly or indirectly, to a member, a director or an officer of the corporation except in furtherance of its activities.
